

Introduction to IQAC

In alignment with the guidelines of the National Assessment and Accreditation Council (NAAC), the Internal Quality Assurance Cell (IQAC) has been established as a statutory body within the institution to foster and sustain a culture of quality enhancement and assurance. In the context of a pharmacy institution, the IQAC functions as a strategic and facilitative unit, with a prime focus on developing mechanisms for conscious, consistent, and catalytic action to improve the academic and administrative performance of the institution.

IQAC plays a pivotal role in promoting quality education in pharmaceutical sciences by integrating best practices, fostering academic innovation, encouraging research, and enhancing student support systems. It also ensures that the institution is prepared for future challenges in pharmacy education by promoting a culture of evidence-based decision-making and stakeholder participation.

Objectives

- 1. To develop and apply quality benchmarks/parameters for the various academic and administrative activities of the institution.
- 2. To facilitate the creation of a learner-centric environment conducive to quality pharmaceutical education and faculty development.
- 3. To promote the integration of emerging technologies and pedagogical innovations into teaching-learning and assessment processes.
- 4. To encourage interdisciplinary research, publications, consultancy, and collaboration with industry, hospitals, regulatory bodies, and research institutions.
- 5. To enhance the effectiveness of student support services, career guidance, and professional development initiatives.
- 6. To ensure timely, efficient, and progressive performance of academic, administrative, and financial tasks through systematic documentation and internal audits.
- 7. To organize workshops, seminars, and quality-related events for faculty, students, and non-teaching staff.
- 8. To develop a mechanism for feedback from stakeholders including students, alumni, employers, and industry experts for institutional improvement.
- 9. To prepare and submit the Annual Quality Assurance Report (AQAR) to NAAC, and coordinate all quality-related activities, including institutional accreditation and re-accreditation processes.

- Arrangement for feedback response from students, parents and other stakeholders on quality-related institutional processes
- Dissemination of information on various quality parameters of higher education
- Organization of inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles.



- Documentation of the various programmes/activities leading to quality improvement
- Acting as a nodal agency of the Institution for coordinating quality-related activities, including adoption and dissemination of best practices
- Development and maintenance of institutional database through MIS for the purpose of maintaining/enhancing the institutional quality
- Development of Quality Culture in the institution
- Preparation of the Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NAAC, to be submitted to NAAC
